The DB 60% equity market had difficult performance in the fourth quarter, hindering results for the target index being down 8.2% vs. down 7.8% as of 12/31/2018. This allocation posted strong results over the past 5 years rising 4.5%, which lags the target index up 5.2%, ranking in the top 49th percentile of its peer group.

Over the past ten years, this allocation is up 8.0% on average annually.

Trustee Levi Alderfer made a motion to approve the payment of \$630.00 to Sugarman Susskind for legal services rendered. Trustee Ty Tolbert seconded the motion. All were in favor, motion carried.

Approve attendees to the 2019 Firefighters' Pension Trustee School

Trustee Levi Alderfer made a motion to approve sponsoring plan trustees and plan admins cost to attend the 2019 Firefighters' Pension Trustee School. Trustee Ty Tolbert seconded the motion. All were in favor, motion carried.

OLD BUSINESS -

Review and discuss IME report for John Clark.

The Trustees reviewed plan member John Clark's IME report. Pedro Herrera addressed the Trustees to inform them, with the completion of the Independent Medical Evaluation (IME) by the board selected medical provider, the trustees must move forward with scheduling a date to offer plan member John Clark an Administrative Hearing.

The Administrative Hearing proceeds much like any other trial. Prior to the hearing, attorneys for both the plan and the plan member are provided the opportunity to conduct depositions and court reporters and mediators are hired and in attendance for the duration of the hearing. Formal Administrative Hearings can be very costly on both the plan and the plan member; therefore, Florida allows plans and plan members a lesser expensive Informal Administrative Hearing option as well. Depositions, court reports and court mediators are not required for the Informal Administrative Hearing. If at the conclusion of the Informal Administrative Hearing, the plan member application remains unresolved, all parties advance to the Formal Administrative Hearing.

Pedro Herrera will provide each of the trustees an electronic copy of the Medical Binder two weeks prior to the Informal Hearing date. The binder will contain Mr. Clark's completed application, signed waivers and copies of all relevant medical records. The day of the Informal Hearing, Chairman Del Rosario will open the meeting to obtain roll call and then turn the meeting over to Pedro Herrera as legal representation for the plan. Pedro Herrera will state the reason for the hearing and direct the Trustees to the five questions, as per FL Stat. 175.191, they must answer in their due diligence to decide this matter. If all questions are answered in the affirmative, per FL Stat. 175.191, the Trustees must find Mr. Clark Totally and Permanently Disabled and award him a disability pension. The Trustees are free to address Mr. Clark and ask any questions they have in reference to information within his medical records as it pertains to the relevant injury. If the Trustees answer all five questions

in the affirmative and award Mr. Clark a disability pension, the Trustees must also decide the effective date which determines the date Mr. Clark will receive his first his disability benefit payment.

Since Mr. Clark now resides in Colorado and two of the Pension Plan Trustees are not in attendance of this meeting, Chief Scarborough will coordinate with all parties and schedule a date for the Informal Administrative Hearing. Mr. Clark is not required to attend the hearing but is certainly entitled to attend the hearing. Mr. Clark is also entitled to a full Board of Trustees at the hearing, attendance is imperative.
